ACTIVITY DESCRIPTION

This immersive, early career program offers those residents, fellows and recent graduates the opportunity to interact with a panel of expert faculty and discuss the 2022 CDC Guideline for Prescribing Opioids for Chronic Pain, changes made since the last Guideline published in 2016, and ways to utilize the new Guideline in the management of pain. Emphasis will be on the need to individualize treatment to the needs of the patient, use of multi-modal pain management strategies, understanding the different pain pathways and biopsychosocial factors individual patients face trying to manage pain.

Targeting residents and fellows in pain management, family medicine, primary care, internal medicine, hematology/oncology, palliative care anesthesiology, psychiatry, psychology, neurology, dentistry, and surgery training programs across the United States.

Jeffrey Gudin, MD completed his residency in anesthesiology at the Yale University School of Medicine and his fellowship at the Yale Center for Pain Management. While in New Haven, Dr. Gudin also trained in addiction medicine and directed a substance abuse treatment center. As Professor at the University of Miami Miller School of Medicine, he remains active in teaching and research. Dr. Gudin has assisted in clinical trial design and the development of numerous analgesics. He has lectured internationally on pain management, palliative care, and addiction medicine, and has served as expert witness on a variety of patent, medical opioid-related, and injury cases.

Dr. Gudin is principal investigator on an National Institutes of Health (NIH) funded analgesic research project through the Helping to End Addiction Long-Term (HEAL) Initiative, by the National Center for Advancing Translational Sciences (NCATS) to study the pharmacology and safety of a novel molecule/ formulation for the treatment of pain.

Dr. Gudin has dedicated his career to promoting education in pain management. He attends and has presented at PAINWeek, the American Pain Society, American Academy of Pain Management, American Academy of Physical Medicine and Rehabilitation, and many other national/ international venues.

Sudheer Potru, DO, FASA, FASAM is a triple-board-certified anesthesiologist, pain medicine physician, and addiction medicine specialist at the Atlanta VA Medical Center, where he serves as the director for the facility's complex pain management clinic. A former Associate Professor, his primary clinical and research interests are in the intersection of opioid safety, substance use disorders, and the perioperative and pain clinic settings. He has published extensively in these domains and serves on national committees for ASA, ASRA Pain Medicine, and the American Academy of Pain Medicine. He has lectured nationally and internationally at numerous anesthesiology and pain management conferences and has given grand rounds presentations at such reputed institutions as the Mayo Clinic, Vanderbilt, and many others. A graduate of Michigan State University's College of Osteopathic Medicine, Dr. Potru completed his residency training in anesthesiology at the University of Miami/ Jackson Health System in Florida and a pain medicine fellowship at Rush University Medical Center in Chicago.

PATIENT ADVOCATE



Jonelle M. Elgaway

Patient Advocate Executive Director National Pain Council Raleigh, NC

Over the last 31 years **Jonelle M. Elgaway** has dealt with major health issues and several incurable/painful diseases. At age 16 she was in an auto accident resulting in broken c3-c4 vertebrae, and a second accident at 25 years old breaking the c4-c5 vertebrae, which left her left arm/hand paralyzed. After surgery and 2 1/2 yrs of intense physical therapy Ms. Elgaway got her arm back, but would go on to have 5 total neck surgeries over the next 10 yrs.

Prior to her surgeries, Ms. Elgaway played on the B squad 1996 Olympic team for field hockey and won an athletic scholarship to The Ohio State University. She graduated with a B.A. in English (Racism, Feminism and Gender) and a minor in International Politics.

Prior to becoming fully disabled Ms. Elgaway worked as an undercover agent at PLE Group, JP Morgan Chase in the mortgage department. As her health worsened, she started a business flipping houses until she became permanently disabled in 2005. Once fully disabled Ms. Elgaway searched for a new purpose and fell in love with patient advocating.

Ms. Elgaway has spoken at a congressional briefing in 2018 concerning how the opioid crisis has affected patients with intractable pain and the doctor/patient relationship. She has met with 40+ senators, state reps, congressman, and governors to discuss the treatment of patients and doctors since the opioid crisis was created.

Currently, Ms. Elgaway serves as the Executive Director for National Pain Council (NPC), LLC. NPC's goals are to provide education and resources to restore equity in the treatment for all patients with intractable pain and to support and protect doctors. Additionally, Ms. Elgaway recently created Pain Round Table, which is a grassroots movement to unite medical professionals and patients within the chronic pain community.

Ms. Elgaway strives to never stop fighting for the chronic pain community until all patients receive the proper treatments and medications to live a better quality of life.
