Activity Description

Pre-exposure prophylaxis (PrEP) is an established and highly effective method of preventing sexually transmitted human immunodeficiency virus (HIV) infections and has been instrumental in declining incidence rates. Adherence and access to HIV prevention still pose challenges due to stigma and false beliefs, and the small fraction of individuals with HIV who are unaware of their status are responsible for a significant number of new cases. Clinicians and multidisciplinary care teams must familiarize themselves with new data on emerging PrEP options to increase optimal and equitable HIV prevention as well as to engage with patients about sexual health in meaningful and compassionate ways.

In this CME Outfitters live symposium, expert faculty will guide learners on the implementation of routine HIV testing and on adopting a status-neutral approach to effectively promote prevention strategies and PrEP initiation. Faculty will evaluate current and emerging PrEP options, introduce emerging LAI PrEP options, and discuss optimal patient selection criteria, transitioning strategies, and monitoring considerations. Faculty will model integration of effective patient engagement strategies to collaboratively initiate PrEP treatment and support adherence.

Professor Division of Infectious Diseases The University of North Carolina Chapel Hill, NC David Alain Wohl, MD, is a Professor of Medicine in the Division of Infectious Diseases at the University of North Carolina (UNC) and the Institute of Global Health and Infectious Diseases. He is co-Principal Investigator of the Global UNC Infectious Diseases Clinical Research Unit and Site Leader of its Chapel Hill research site.

Dr. Wohl is a clinical scientist with a focus on emergent infectious diseases. He has spent over 25 years leading research into the prevention and treatment of HIV and served two terms as a member of the US Department of Health and Human Services (DHHS) Antiretroviral Guidelines Panel.

Since 2014, he has been working continuously in Liberia, West Africa, conducting research with Ebola survivors to learn about chronic complications and sexual transmission of this infection and establishing the UNC Project-Liberia research platform at two locations in the country. He and his team have extended this work to examine Lassa fever, a viral hemorrhagic fever endemic in West Africa.

In 2020, he contributed to the UNC clinical and research response to COVID-19. He was medical director of the UNC Chapel Hill drive-through testing site as well as two COVID-19 vaccination clinics and the Chapel Hill COVID-19 monoclonal antibody infusion center. He serves as a co-chair of ACTIV-2, an international platform trial of promising SARS-CoV-2 therapeutics.

In 2023, UNC was selected by the US DHHS to be a designated Regional Special Pathogens Treatment Center, one of only 13 in the country. Dr. Wohl has an active clinical practice at UNC Infectious Diseases Clinic.
